# History of Standards for Quality Assurance in Africa

- Early tertiary began by colonial masters in 1920s
- University affiliation to western universities
- Post-independent governments stressed the need for quality education
- Establishment of accreditation institutions for quality curricula
- Affiliation to chartered institutions
- Set up of national quality assurance agencies
- ACTEA set standards on theological education



# ACTEA Standards and Procedures for Accrediting Secondary Level.

- Administration
- Teaching staff
- Facilities
- Educational programmes
- Students



# Accreditation

It is a process of self-study and external review to scrutinize institutions for quality standards and improvement.

The Process usually includes:

- Self-evaluation
- Peer review
- Site visit



# Quality Assurance

It is a planned and systematic review process of an institution or programme to determine whether or not acceptable standards of education, scholarship and infrastructure are being met, maintained and enhanced.



# Categories of Quality Assurance

- External quality assurance
- Internal quality assurance



# Quality Assurance and Standards in Kenya

Is a function of the directorate of quality assurance and standards which is a professional arm of Ministry of Education.

## Objectives:

- Regular reporting to the Ministry of Education on quality education in the country
- Monitoring performance of institutions
- Ensure equitable distribution of tutors
- Carry out regular quality assurance and standards assesment.
- Advise provision of edequate facilities
- Ensure appropriate curriculum is operational
- Administer co-curriculum activities to develop an all-round person
